BOND AGREEMENT

For and in consideration of a bail bond being posted for my jail release, I, _____, do hereby agree to the following as evidenced by my signature below:

NOTICE: BAIL JUMPING AND FAILURE TO APPEAR

FAILURE TO APPEAR IN COURT MAY RESULT IN BAIL JUMPING/FAILURE TO APPEAR CHARGES BEING FILED AGAINST YOU. BAIL JUMPING CAN BE A THIRD DEGREE FELONY PUNISHABLE BY IMPRISONMENT FOR ANY TERM OF NOT MORE THAN 10 YEARS OR LESS THAN 2 YEARS AND AN OPTIONAL FINE NOT TO EXCEED \$10,000.00. TEX PEN. CODE § 38.10.

1. I agree not to depart the jurisdiction of the court I am charged or the county that I have provide to ALL HOURS BAIL BONDS as my residence for more than 72 hours without prior written permission from ALL HOURS BAIL BONDS.
2. I agree to IMMEDIATELY notify ALL HOURS BAIL BONDS of any change in my address, telephone number, and employment.
3. I agree to IMMEDIATELY notify ALL HOURS BAIL BONDS of the name and contact information of any attorney I employ or am appointed to represent me on any charges in which I have made bond for.
4. I agree to pay the fee charged for my bond(s) and make all payments agreed to in any Payment Agreement timely to ALL HOURS BAIL BONDS.
5. I agree to check in WEEKLY with ALL HOURS BAIL BONDS by telephone at (325) 236-8000 or (325) 219-1942 between the hours of 9:00 am and 5:00 pm each week beginning on the WEDNESDAY following my bond being posted and each WEDNESDAY thereafter until my bond(s) are exonerated.
5. Although ALL HOURS BAIL BONDS will make effort to notify me, I agree and understand that is my responsibility to know my own dates to appear in Court and to appear as directed by the Court.
6. I agree and understand that if I am incarcerated on any other charges or are arrested for other violations of the law, it is a violation of the conditions of my bond(s).
7. I agree that in the event I fail to appear to appear as ordered, I shall be responsible for the entire amount of bond(s) posted, all costs associated to secure my apprehension, court costs, and warrant fees.

I UNDERSTAND AND AGREE THAT A VIOLATION OF THE ABOVE CONDITIONS OF MY BOND AGEEMENT MAY RESULT IN THE ISSUANCE OF A WARRANT FOR MY ARREST, FORFEITURE OF MY BAIL BOND, A JUDGMENT, AND ORDER OF DETENTION. ANY CRIMES COMMITTED WHILE ON BOND ARE GROUNDS FOR BOND REVOCATION.

I acknowledge that I am the accused and that I am aware of all conditions of this agreement. I promise to comply with all conditions, to appear as directed, and to surrender for any sentence imposed, if any. I am aware of the penalties if I should violate any conditions of this agreement with ALL HOURS BAIL BONDS.
